

White Bird Clinic Report



Impact Your Health Eugene

Caring Hands held their seventh annual Impact Your Health event at the Lane County Fairgrounds in the Performance Hall on November 13th and 14th. These events usually serve as many as 1,000 people. This year, due to Covid-19 safety concerns, the event served about 150 people. Those needing dental care had the choice of scheduling an extraction, filling, or cleaning.

Many of the volunteers, including dentists and doctors have been volunteering with Caring Hands for many years and plan to continue for many more years to come. Anna Nelson has been volunteering with Caring Hands since she was in high school. She has assisted in clinics around the world. Dr. Wilson travelled from Wyoming to join local doctors, providing medical assistance as needed.
